p.13	C.B. 27 April 1620: Isabella Carr who held by copy of court roll, 1 cottage in Oldnall End, died since last count. Herriot: 1 black heifer value 12s. John Matthew is next heir and is under 21 years.
p.82	C.B. 8 April 1724: Thomas smith, churchwarden, sought permission to demise to John Carr, 1 cottage in Cornest End for 21 years. Fine: 1s.9d. Granted
p.87	C.B. 24 April 1728: William Carr elected Constable
p.91	C.B. 21 April 1731: Edward Carr died since the last Court siesed of a free estate. 1 relief. Thomas his son is heir.

	<u>From the will of Mary Adcock of Meriden (died Oct.1770)</u> “to Mrs Smith of Berkswell, wife of Robert Smith, my “Josephus” (a book), then to her daughter Mary Carr” This would be Robert Smith and Mary Carr, widow, who were married at Holy Trinity, Coventry, on 24 th August 1744 (the marriage is recorded in Berkswell Parish registers). She was previously married to John Carr – I haven’t found the marriage yet. I think she was probably the daughter of Joseph and Elizabeth Gibbs who were married in the will of William Sleath (died 1730).

Left: all to wife Mary, to be sole executor

Date of Inventory: 5th April 1704

House: his Lodging Room, the Mans Room, Room over Hall, Room beyond Dairy, Best Chamber, the Maids Room, Parlour, Dairy, Hall

Total Value of Inventory = £139.2s.0d. (including farm value, £70.11s.0d.; hemp, hempen yarn, jarsey, etc. £1.8s.3d., malt, barley, cheese, etc. £9.10s.0d.; woollen yarn and a salt tub, 18s.8d.)

(2) EDWARD CARR, baker (Probate 8th April 1731)

(3) JOHN CARR, mercer (Probate 10th October 1741)

Date of Will: 25th July 1741 (weak in body; signed)

Family and bequests:

to wife Mary: all lands and copyhold estate in parishes and manors of Barston and Berkswell which are not settled upon her for her jointure for life.

to son John: after her decease to my son John those two several houses in Berkswell in a place there known by the name of Berkswell Church End and now in the occupation of William Kerby and Samuel Greswold or their under-tenants for ever according to the custom of the said manor.

to son William : all land and copyhold estate in manor of Barston

to daughter Mary : £50 when 21

to wife Mary: 'the rest'

Mary (wife?, or daughter?) to be executrix

Witnesses to Will: John Savage, Hnery Watson, Jos. Benton
